The election meeting was held on Monday, November 29, 2021, in the Clubhouse of the Park East Home Owner's Association (110 NW 87 Ave, Miami, FL 33172). Election Monitor, **Tomas Rementeria**, conducted the election. The election meeting began at 7:30 pm, polls were closed at 7:45 pm and the election ended at 8:26 pm.

Property Manager Fernando Garrote and Attorney William Essig, Esq. were present for the association.

A total of **one hundred & four (104)** ballots were received from the **three hundred & seventy-eight (378)** unit owners. **Eight (8)** candidates were competing for **seven (7)** director positions.

After the meeting was called to order, **three** (3) committee members were appointed to perform the envelope validation process and to tally the votes under my procedural direction and in the presence of the membership.

The Board provided me with a current qualified voter list that was used for voter verification. All ballots received by management were stamped on the front top center of the outer ballot envelope. All ballots received at the meeting by voters were stamped on the front lower left side of the outer ballot envelope. During the voter verification phase of the election a total of **three** (3) ballots were disregarded: **two** (2) ballots were cast by non-owners, and **one** (1) ballot had voted more candidates than allowed.

All election materials were placed in the custody of Fernando Garrote for the required one-year duration.
